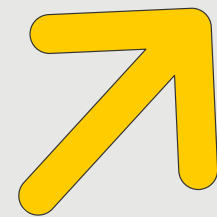

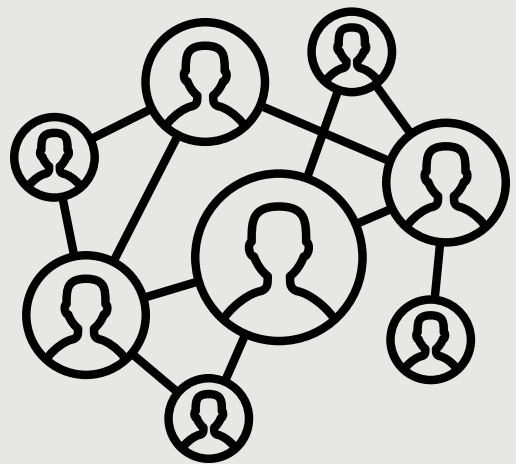

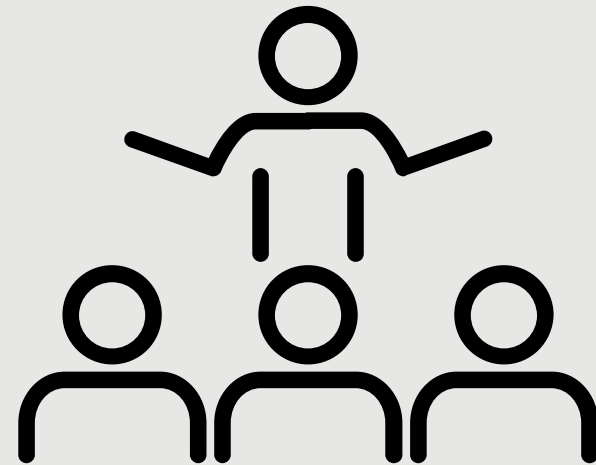
The ECCK is a member-based organization, fully self-financed and therewith politically independent.

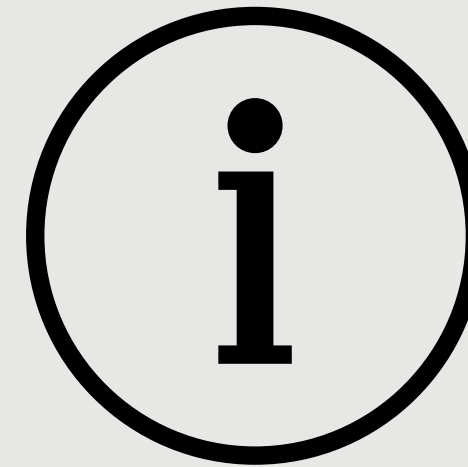

In 2025, ‘ECCK White Paper’ including 70 recommendations handed over to the Korean government, shared with the European Commission, EFTA, UK government.



➤ OUTREACH

The ECCK also actively engages in Committee Outreach initiatives.

Notably, the IPR Committee has been consistently leading anti-counterfeiting campaigns. These efforts include providing training sessions for municipal officials responsible for counterfeit enforcement and sharing consumer awareness guides to educate the public on the risks associated with purchasing counterfeit goods.

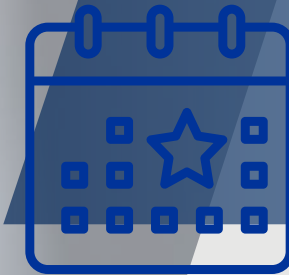
